

### How did the Fund perform last year?

**Large-Cap Value ProFund** (the "Fund") seeks investment results, before fees and expenses, that track the performance of the S&P 500<sup>®</sup> Value Index (the "Index"). The Fund invests in financial instruments that ProFund Advisors believes, in combination, should track the performance of the Index. For the year ended July 31, 2024, the Fund had an average daily statistical correlation of over 0.99 to the daily performance of the Index. For the same period, the Index had a total return of 16.78% and a volatility of 10.67%. The index performance was driven by the strong equity environment, though its returns lagged the S&P 500<sup>®</sup> in part due to a relative underweight to technology. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of a Fund's index, and other miscellaneous factors.
