- Overweighting a market segment without additional cash

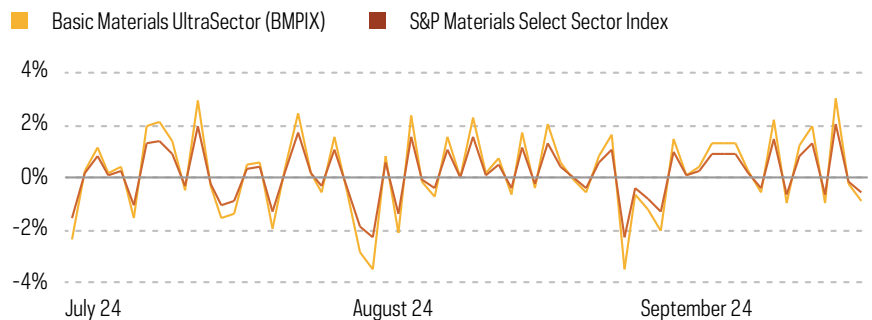

Daily return during 3Q 2024



Many ProFunds seek daily investment results that correspond, before fees and expenses, to a multiple (e.g., 2x, -2x) of the daily performance of its underlying benchmark (the "Daily Target").
