
- Seeking magnified gains (will also magnify losses)

Component companies include, among others, leading miners and producers of gold, silver and platinum-group metals whose securities are available to U.S. investors during U.S. trading hours. It is a float-adjusted, market capitalization-weighted index. It is not possible to invest directly in an index.


