- Overweighting a market segment without additional cash

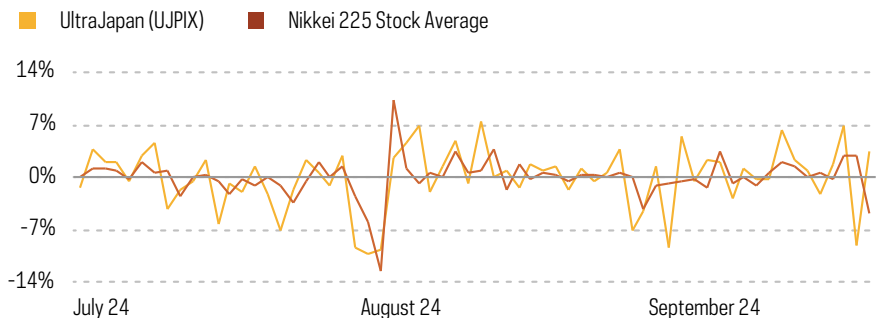

Daily return during 3Q 2024



<h2>Index description ²</h2> <p>The Nikkei 225 Stock Average Index (Bloomberg symbol: NKY) is a modified price-weighted index of the 225 most actively traded and liquid Japanese companies listed in the First Section of the Tokyo Stock Exchange ("TSE"). The Index is calculated from the prices of the 225 TSE First Section stocks selected to represent a broad cross-section of Japanese industries and the overall performance of the Japanese equity market. It is not possible to invest directly in an index.
