Fund objective

UltraShort Nasdaq-100 ProFund seeks daily investment results, before fees and expenses, that correspond to two times the inverse (-2x) of the daily performance of the Nasdaq-100® Index. The Fund does not seek to achieve its stated investment objective over a period of time greater than a single day.

Fund performance and index history²

The UltraShort Nasdaq-100 ProFund seeks daily investment results, before fees and expenses, that are -2x the return of the Nasdaq-100® Index (the "Index") for a single day, not for any other period.

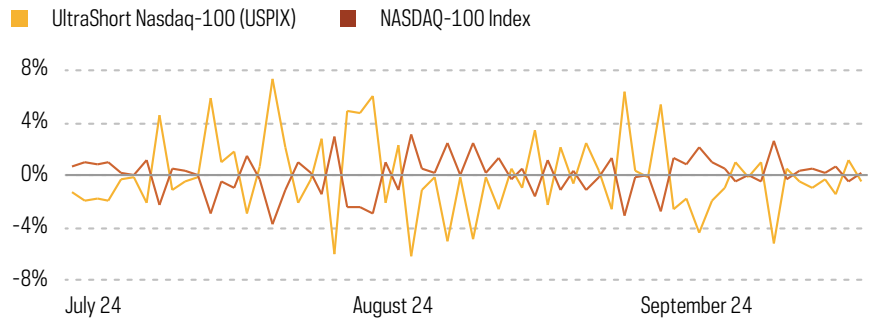

Common uses for inverse exposure include:


- Helping to hedge against declines
